The Annie C Courtney Foundation, as managing partner of the Foster, Adoptive and Kinship Coalition Team, created a \$1000 scholarship in the loving memory of Katherine “Kay” Wyrick, whose outstanding volunteer work has touched and changed the many lives she came in contact with.

Kay Wyrick was born on May 18, 1923 and resided in Waterbury for many years. Mrs. Wyrick was a long time activist and volunteer on behalf of abused, neglected and pregnant youth. She surmounted overwhelming odds to become a role model for those who cared about others. Mrs. Wyrick was a ward of the state from the age of 13 to the age of 21. She was brought to Waterbury as a domestic caretaker. Several years later, she decided to become a foster parent. Mrs. Wyrick and her husband nurtured over 75 young adults by helping them stay off the streets develop good work habits and learn the value of money. She established a group home for girls. Mrs. Wyrick crusaded against racial injustice throughout her life. She was a lifetime member of the NAACP and fought to have Black History taught in local schools.



Over the course of 55 years of service, Mrs. Wyrick received numerous awards for her commitment to young people. She was honored by the Waterbury Bar Association as the first recipient of the Liberty Award. She was also honored by the NAACP as the first to receive the Region II Youth Advisor Award. She was one of the five people to earn the Connecticut Jefferson Award given to people who go above and beyond the call of duty volunteering in their community. Mrs. Wyrick won the Hiram Hayden Award that recognizes those who have given their time and talent for the betterment of their fellow citizens. She also received the Humanitarian Award by the Andersons Boys Club. In 1999, Mrs. Wyrick was honored as an outstanding parent for National Parents Day. She was one of eleven people selected for the nationwide tribute that acknowledges parents who are working to keep children safe, healthy and drug free. Mrs. Wyrick was the founder of the PRIDE NAACP YOUTH CENTER located in Waterbury, Connecticut where she volunteered her time to deprived youth. On July 12, 2006, at the age of 83, Mrs. Wyrick passed away. She had consistently devoted her time to the development of young people. She encouraged children to get an education and pressed parents to be involved in their children's educational goals. She urged men to be fathers to their children and she encouraged adults to be role models to youth. Mrs. Wyrick's determination and dedication set her on a path from which she never deviated. Mrs. Wyrick, a wife, a mother, and an inspiring mentor illuminated the lives of many people.

Scholarship Eligibility Requirements

You must meet the following criteria to apply for this scholarship

- Students must be a high school senior and enrolled as a full time student.
- Student should have been in foster care for one consecutive year at some time in his/her life.
- Student must be a resident of Connecticut
- Student should have a G.P.A of a C (2.0) or better
- Student should be a child of color, preferably African American or of African ancestry
- Student should major in a field related to working with children in the community (Social Work, Human Services, Sociology, Psychology, Criminal Justice, or closely related field)
- Student must be accepted into or enrolled in an accredited post-secondary program (University, College or Community College)

Application Checklist

- Copy of official or unofficial transcript from most recent school attended
- Two page, double space typed essay
- Application release form
- Copy of acceptance letter

Please note: Once awarded, scholarship will be mailed directly to the post-secondary school that recipient is registered to attend. Funds will only be available through the school. Scholarship awardees will receive the first installment of their scholarship (\$500.00) upon submitting proof of registration at an accredited post-secondary program (University, College or Community College). The second installment of the scholarship will be awarded after receipt of student's transcript including all grades from first semester. A minimum GPA of 2.5 (B-/C+) or better and no failing (F) grades in any classes will be required for release of the second installment of the scholarship monies. Awardees who fail to submit required transcript in a timely manner will forfeit the remaining scholarship monies. Awardees who do not maintain the required GPA will also forfeit the remaining scholarship monies.
